# Biography

Michal joined Stockwoods after over two decades with the Ministry of Attorney General - Crown Law Office Criminal, where she was General Counsel. In that role, she has argued over twenty-five appeals before the Supreme Court of Canada and over a hundred in the Ontario Court of Appeal, many of which have become the leading cases on significant issues in Canadian law. As General Counsel, she has been repeatedly called on to lead large counsel teams on particularly sensitive, complex, and high-profile trials and appeals. She is an extraordinary, confidence-inspiring litigator who has earned a reputation with all levels of court and the bar as a tough, but fair advocate. She is as comfortable running a first-degree murder or fraud trial with international dimensions, as she is with arguing a complex and ground-breaking constitutional issue before the Supreme Court of Canada.

Michal is proficient at providing strategic counsel, having routinely advised the highest levels of government and high-ranking police and regulatory officials on privacy, search and seizure, domestic and trans-national criminal law issues, and electronic surveillance problems. During her many years as Electronic Surveillance and Complex Search Co-ordinator for the Province of Ontario, she advised on some of the most difficult emerging issues related to domestic and international privacy.

In her current practice, she defends and advises clients on these and related problems, including the challenges created by emerging technologies, foreign corrupt practices issues, privacy compliance, and both regulatory and class action litigation emerging from competition and securities regulation.
